Reminder of the Village of Morley Blight Ordinance

“What is blight?” The simple answer is any junk, garbage, building material or building that is unsightly. The Village of Morley has a blight ordinance and you will be warned and then ticketed if your property contains blight.

Some excerpts (more information is contained in the full ordinance) -

Prohibited Conduct—storing, accumulating or permitting the storage or accumulation of junk or garbage; storing or accumulating building materials for any period longer than reasonably necessary but no longer than 60 days; permitting the existence of any blighted structure; or storing firewood that is not neatly and orderly stacked to a height of no greater than five feet. Vacant buildings must be maintained.

No graffiti is allowed in any form, including words, symbols, or drawings. No outside placement of indoor furniture. It is unlawful to allow any fence, gate, wall or similar structure to sag, lean or have missing boards or bricks or to be fallen over or collapsed.

No placement of any object is allowed in the public right-of-way. Portable tents, shelters, canopies and tarps are not permitted on any property if used in front yards and street side yards for permanent use. Temporary (no longer than 30 days) use is allowed.

Our Village policemen will enforce this ordinance. They will notify the occupant who will have 30 days to remedy the violation. If it is not remedied, then a ticket will be issued. The first offense will be \$100; second offense \$150; third offense \$250.

Village of Morley Clean-Up 2020 Begins April 1 and ends October 31

Leaves, Grass Cuttings, & Brush will be picked up April through October. On the **FIRST MONDAY** of each month brush will be collected. Please do not stack the brush too high and put the butt ends toward the road. On the **LAST MONDAY** of each month leaves will be collected. Yard waste must be in biodegradable/compostable bags (no regular plastic trash bags accepted). Brown paper yard waste bags and/or “Bag to Nature” 100% compostable plastic bags are available at Wal-Mart, Lowe’s, Menard’s, etc. Stack bags and brush at your curb. Please be considerate of our maintenance worker by loading bags that one person can easily carry. **PLEASE DO NOT BRING YOUR ITEMS TO THE MAINTENANCE BUILDING OR ANY OTHER VILLAGE SITE—VIOLATORS WILL BE PROSECUTED.**

Please Note: We will **NOT** be collecting your normal kitchen garbage and we will **NOT** be collecting “bulky” items, such as lawn chairs, furniture, appliances, etc. Because the Village has contracted with Republic Services so you can obtain rubbish service at a greatly reduced amount, these items can be collected by them (as long as you have obtained service through them).

No Hazardous Materials are accepted at any of the Cleanups: No Liquids, Paint, Concrete, Shingles, Tires, etc. are accepted. Mecosta County Household Hazardous Waste Collection will be Saturday, Oct. 9, 2021, 9-noon, at the Mecosta County Fairgrounds, 540 West Ave., Big Rapids.
